Chief of Staff, Office of Elementary and Secondary Education, U.S. Department of Education

Prior to her position on the Committee, Ms. Valtierra worked to promote equitable school policies for girls of color and represented pregnant and parenting students at the National Women's Law Center. She has also represented immigrant children and families and is a former 7th grade English teacher. She holds a Bachelor of Arts in political science from the University of Illinois at Urbana-Champaign and a J.D. from the University of Wisconsin Law School.

Public Health Advisor, Centers for Disease Control and Prevention

Ms. Jyotsna Blackwell joined the Centers for Disease Control and Prevention as a Public Health Advisor ten years ago. She works in the Division of Population Health, Healthy Schools Branch and serves as a Project Officer for Louisiana, Massachusetts, Minnesota, and Oklahoma.
